
As a concerned resident of Santa Ana, I am calling on you to take immediate action to restore the integrity of our Police Oversight Commission by hiring an Independent Director without further delay.

The commission was created to ensure transparency, accountability, and justice in policing — but for nearly years, it has been paralyzed due to the City's failure to fill the Director role. In the meantime, Santa Ana police officers have shot and killed multiple residents. Without a Director, the commission cannot investigate these incidents or respond to community complaints. The Director is essential for initiating investigations, issuing subpoenas, and producing public reports—core functions that empower the Commission to hold the police department accountable. The one-year legal deadline for launching investigations is quickly approaching, risking the loss of any path toward accountability.

These delays are not just bureaucratic oversights — they have real and devastating consequences. Families are grieving, communities are demanding justice, and trust in local government continues to erode.

I urge you to act now: immediately appoint an Independent Director and ensure that funding for the position is preserved in the upcoming budget. Santa Ana's residents have waited long enough — the time to fulfill the purpose of the Police Oversight Ordinance is now.

SANTA ANA, Calif (KABC) -- Business owners throughout Santa Ana said the presence of Immigration and Customs Enforcement (ICE) officers, ongoing raids and the presence of the National Guard have hurt sales as a large part of the community stays home in fear.

The presence of the National Guard outside the Ronald Reagan Federal Building and U.S. Courthouse downtown has brought demonstrators to the area and kept customers away.

The loss has been very noticeable for Laura Diaz, the owner of the restaurant Perla. Diaz said she has seen about a 90% drop in business because of fear in her community caused by ongoing immigration raids throughout Orange County and the military presence directly in front of her restaurant since Monday night.

Tuesday morning, the calls started coming in. An event on the second floor and a large reservation, a table for a party of 25, were canceled.

Diaz said Santa Ana is a city with a large immigrant population, and all of the disturbances created by the presence of ICE and the raids have left the entire community shaken." ICE OUT OF OC





My name is Kirk Carlson, and I'm a retired U.S. Marine and the founder of Covenant of Courage, a nonprofit dedicated to protecting the dignity and rights of injured veterans through advocacy, education, and policy reform.

I respectfully submit the following public comment for your review and consideration:

Public Comment – Endorsement Request for #ReasonableRanks Veteran Advocacy Campaign

Each year, thousands of service members are involuntarily discharged after sustaining injuries in training or non-combat settings — not for misconduct, but because they are deemed non-deployable. Current military policies offer no reassignment path, even for those still capable of serving in support or administrative roles.

The #ReasonableRanks campaign seeks to reform this system by aligning military discharge practices with ADA protections and Equal Protection Clause standards, ensuring that injured but capable troops are not unfairly removed from service.

The City of Corona recently issued a formal Letter of Support for the campaign (attached), recognizing that this issue affects military families across Southern California. We are now requesting the same from the City of Santa Ana, a city known for its strong commitment to equity, inclusion, and veteran support.



On Father's Day morning, federal agents detained a local man in Santa Ana's Artesia Pilar neighborhood around 10:30 a.m. on Sunday.

Local residents, who witnessed the detainment, told Voice of OC it happened in about eight minutes – noting the man was a longtime resident of the area who collected cans and bottles for recycling on Sundays. Solorzano said it falls on the community to protect itself – something that he says the recent protests are spurring people to do.

“We are going to save ourselves, we are going to save the neighbor. Not the mayor, not a city council member. We have to start thinking like that – like during the pandemic.”

Equally important as the strategy of desensitization is something they referred to as “jamming.” According to the authors of *After the Ball*, “Jamming makes use of the rules of Associative Conditioning (the psychological process whereby, when two things are repeatedly juxtaposed, one’s feelings about one thing are transferred to the other) and Direct Emotional Modeling (the inborn tendency of human beings to feel what they perceive others to be feeling.)”⁵ One means of accomplishing this is to unfairly associate everyone who opposes homosexuality with the radical beliefs and actions of fringe extremists. - **Legal challenges:** Some of these executive orders are facing legal challenges, with one federal judge issuing a preliminary injunction against portions of the DEI and Environmental Justice EOs. The long-term impact of these orders may depend on the outcomes of this litigation.
- **Uncertainty and lack of clarity:** There is ongoing uncertainty about what specific DEI activities or programs are considered "illegal" under the executive orders.
- **Continued need for anti-discrimination efforts:** Organizations must continue to comply with federal and state anti-discrimination laws, and eliminating all DEI programs could increase the risk of discrimination claims. [🔗](#)

Key Impacts on Large Nonprofits:

- **Potential loss of federal funding:** Nonprofits that rely on federal grants, particularly those focused on DEI initiatives, may be at risk of losing funding if their programs are seen as prioritizing certain demographic groups over "merit-based" criteria.
- **Increased scrutiny and potential investigations:** Large nonprofits (those with assets of \$500 million or more) could be subject to investigations by federal agencies regarding their DEI practices.

Hello,

At a moment of U.S. history that echoes 1930s Germany, fascism has entered our sanctuary city in the form of ICE raids supported by an unprecedented federal military occupation. Community members are being disappeared without due process in violation of the Constitution. In these precarious times, our community members—families, parents, workers, contributors to our culture and economy—are being snatched up by masked officers in unmarked vehicles like a modern-day Gestapo.

In response, the community has activated to exercise our First Amendment rights in peaceful protest of these draconian attacks from an authoritarian federal government. While a small percentage of these protests have devolved into acts of violence against property, that pales in comparison to the widespread acts of state violence against human beings committed by ICE, the Department of Homeland Security, the National Guard, and the U.S. Marines.

In defiance of state law—Senate Bill 54 limits cooperation between local law enforcement and federal immigration authorities—the Santa Ana Police Department responded to peaceful protests last week by marching in militarized riot gear, firing pepper balls and rubber bullets, deploying tear gas against residents. This is not normal. It is unacceptable.

Unfortunately, instead of strong leadership, we get [comments from Mayor Amezcua](#) that are vaguely noncommittal at best, and recklessly false at worst. For example, she explained why she didn't join protesters in the streets because "I don't represent just one group of the community." So who are the other groups she represents, besides those who are being kidnapped and those who are protesting the kidnappings? It seems there could only be one group left for her to represent: those who are doing the kidnapping.

Mayor Amezcua also claimed on Facebook that the protests were violent and destructive, but media sources refuted that claim by reporting only minimal property damage following the protests. By demonizing peaceful protesters who are reacting to oppressive fascism, and refusing to stand up in support of those affected by violent illegal ICE raids, Mayor Amezcua is making it clear that the only people she stands with are the fascists.

We the people demand accountability from our leaders. We demand the demilitarization of our communities. We support peaceful protesters who express their First Amendment rights. We proudly embody the default setting of all decent human beings: anti-fascist.



Dear Clarvida Directors,

I am a 3rd party concerned citizen requesting a response. I kindly request you reply immediately to this email or Mass Resistance.

Please be advised I have received and reviewed copious amounts of writings, recordings and other documentation that suggests your OC Wellness Centers are engaging in illegal conduct. Furthermore, I have been made aware of the existence of video footage showing one or more Clarvida employees engaging in prohibited Hate Speech against Christianity. To be specific, the speech contained slurs against the Judeo-Christian Scriptures.

My original objective was to inquire about the month long LGBTQIA+ activities, and the event planned on the day of the Stonewall anniversary. However, after exhaustive research; I have come to the conclusion that the atmosphere of your facilities is not just pro-Queer, it is **specifically** anti-Christian.

I would like to grant you/us the opportunity to prove me/us wrong. With this in mind, I am including a series of questions that can easily be answered as "Yes" or "No".

I request you reply and respond to my questions exactly like that. Y or N.

Instead of the word <member> I will use the term Patient, because this is what they seem to be.

For all the following please reply Y/N

Clarvida Wellness Center services Patients but calls them members.

They are assigned serial numbers that are basically the equivalent of a Medical Record Number (MRN).

The Social Agreement is used as a substitute for a Patients Rights and Responsibilities Form, in violation of established Health Care protocols.

Clarvida is a "Large Nonprofit", making it subject to President Trump's Executive Order regarding DEI.

Clarvida received and continues to receive a significant amount of Federal funding.

Clarvida maintains, or permits a hostile environment against Christians.

A Clarvida employee was filmed a few days before Holy Week 2025 stating the Bible is the cause of slavery and violence against women and that because Jesus was "born a Jew", He would support that mindset.

Clarvida employees have aggressively prohibited Christians from quietly praying.

Clarvida employees have militantly enforced the mandatory use of 3rd parties preferred pronouns. This was done even when the 3rd party in question was not within earshot, and therefore could not have been offended.

Clarvida withholds ongoing services from Patients or Program Participants who complain.

Clarvida uses food to lure undernourished people into LGBTQ+ activities.

Clarvida engages in grooming behavior by promulgating LGBTQ+ activities to Patients, at least some of whom have severe and significant Cognitive delays.

Some of the Patients induced into participation of gay pride have drastically diminished mental capacity.

Some of the Patients have severe psychosis and are unable to make rational, informed decisions about their sexual choices.

Some Patients have objected to the pride activities being held all month long and were told to not come if they didn't like it.

Clarvida has not provided an alternative activity during the designated time frame of the Stonewall day celebration.

Clarvida canceled a Trauma Recovery group in order to celebrate Stonewall day. This occurred because the group facilitator, Freddy Fernandez is a homosexual and demanded the Stonewall day event take precedence over the Trauma Recovery group.

Trauma Recovery is for everyone, including those who live the homosexual, transsexual or nonbinary/ genderqueer lifestyle.

Clarvida's Wellness South Calendar shows another pride event on June 26th - the 10 year anniversary of Obergefell vs Hodges.

Clarvida staff picked those dates with surgical precision to align with historical events that celebrate days considered to be LGBT+ milestones or victories.

Clarvida staff will not allow Christians, or for that matter any other Abrahamaic religion to attend the Stonewall day celebration and quote the Judeo-Christian Bible, including verses in the Torah or the New Testament regarding homosexuality.

Clarvida staff will not allow anyone to state facts contrary to LGBT+ programming. For example, that there are only 2 genders, or articulate the belief that every member of Humanity was created male or female.

Clarvida staff will not allow anyone to offer their view that marriage is the Sacred union of one male and one female.

Clarvida staff will not allow anyone to articulate the viewpoint that gender is biological and immutable.

Clarvida will not permit anyone to mention programs like Courage which advocates for compassionate treatment and respect for the same-sex attracted, while guiding and encouraging them to choose celibacy.

Clarvida will not allow anyone to mention Reparative Therapy, but freely doles out information about how to obtain gender changing hormones and even surgery.

By imposing these speech restrictions, Clarvida is deliberately promoting one worldview or ideology over another.

At least a few Patients who identify as Atheist or non-Religious have complained the incessant gay centered activities were too much and promoted over regular activities.

Clarvida does not inform Patients of their Rights to make grievances directly to the County's Health Care Agency. (OCHCA)

This concludes my questions, at least for now. Please strive to respond within 2 business days so the situation can be appropriately assessed.

Dear City Councilmembers, City Staff, and Valerie Amezcua,

My name is Arcelia Gutiérrez and I am a resident of Santa Ana in the French Park neighborhood. I write to express my gratitude to council members Jesse López, Benjamin Vázquez, and Johnathan Hernández for their exemplary leadership during this last week and a half. When our city faced devastating Immigration and Customs Enforcement (ICE) raids, police brutality against protesters, and the militarized presence of the National Guard, councilmembers López, Vázquez, and Hernández were on the front lines protecting their constituents and defending our first amendment rights.

I write to request that the City of Santa Ana implement a community alert system to notify residents when ICE operations are occurring in our area. A transparent alert system would allow residents to make informed decisions and take necessary precautions to protect themselves and their families. I also request the City of Santa Ana formally oppose the presence of the National Guard in our city.
