Good morning,

To the planning commission, I hope this email finds you well. My name is Angela Vera and I, along with my sister and brother in law, own the residence located at 2110 Magnolia Avenue in the city of Santa Ana. I was born and raised in the beautiful city of Santa Ana and was raised in this home for over 25 years. Throughout these years, I have been a witness to different city plans that the city has implemented. Some of these plans have changed the city for better, and some for worse. I received through mail a city letter by the Planning and Building Agency informing the residents living approximately 1,000 feet from a potential Starbucks location being built at the empty lot of 2235 S. Bristol Street. I felt very disappointed after reading that a meeting was scheduled for today on Monday, November 25th, 2024 due to being a holiday week and most people travel out of the city. Therefore, I am emailing my concerns and thoughts about this project.

After reading articles about the “Starbucks Effect” and how it increases home and property value, I am also concerned for the well being of my family and my neighbors.

My residence is located on the west side of Magnolia Avenue. A few years ago, the city knocked down the business located on the east side of Bristol Street with a prosperous plan that the

city was going to plant trees and make it a green area. It's been years that the city has not built anything and has only caused transients to break into the wire fence facing Bristol Street and loiter around at night, subjects tagging, along with other issues.

After this occurred, the amount of traffic in Magnolia Avenue has increased tremendously. As a resident, I've seen the amount of traffic that happens on Magnolia Avenue on a daily basis by countless vehicles who enter off of Magnolia Avenue and exit either onto Warner Street or St. Gertrude Street. The frequent number of vehicles that travel on Magnolia Avenue create heavy traffic, unsafe hazards, and visibility for the residents living on this street especially during traffic hours. Another issue the residents of Magnolia have to deal with is parking. After this Starbucks is finalized, I could only imagine the amount of additional vehicles that will be parking on Magnolia Avenue due to the Starbucks parking lot being at its full capacity. In addition, another issue the residents of Magnolia have to deal with is the amount of transients who walk and travel on foot and on bicycles on Magnolia Avenue. With the addition of a Starbucks location on the corner lot, as I have seen on the Starbucks located 2302 S. Bristol Street, it has attracted a number of transients. I've seen transients being verbally aggressive with customers, security guards, loitering in the patio area refusing to leave the property. Transients who are under the influence and refuse to accept help. I've seen subjects overdose on substances sitting on the same tables and benches that our children and families sit in making it unsafe for them. I fear for transient encampments being built near the area just like they did on the empty lots on Bristol Street. I am concerned for the children, our elders living on Magnolia Avenue who will no longer feel safe riding their bicycles on the

block, walking their dogs, or going for a walk due to the amount of transients this Starbucks might attract.

I don't discourage this project from happening but I am curious to know how the city of Santa Ana, and the Building and Planning Agency will work with the residents of Magnolia Avenue referencing the concerns I expressed.
