Dear Members of the Santa Ana City Council,

On behalf of the Anti-Defamation League (ADL) Orange County/Long Beach Region, we write to you with concern over the proposed resolution by the City of Santa Ana Councilmember Vasquez.

Following Hamas' horrific terrorist attack on Israel on October 7 and the ensuing war in Gaza with a large humanitarian toll, it is understandable that calls are intensifying for an immediate ceasefire. We all hope for a cessation of hostilities, the return of all the hostages, a respite for the affected civilians in Gaza, and a future of peace and security for Israelis and Palestinians.

While the ceasefire resolution is seemingly a well-intentioned effort for the city of Santa Ana to make a statement about the Israel-Hamas conflict, the ongoing war is nuanced and such statements require careful consideration in its potential impact on affected communities. We are concerned with the precedent that such a resolution could set in commenting on future conflicts – further dividing the City of Santa Ana. Additionally, this resolution is a second attempt to address this issue after the first resolution didn't pass while fomenting hostilities in the city.

Our elected council represents broad and diverse constituencies. City councils are not tasked with creating positions on behalf of the United States as it relates to foreign policy. And such city council resolutions and statements are simply declaratory in nature – further pulling the community apart. We would suggest that it would be more constructive, and aligned with the role of these elected bodies, to introduce measures to bring communities together, rather than sow divisions. Words matter and in the fight against hate, action is just as important.

Furthermore, as we have seen across the country, the introduction of these resolutions has been used in many cases as an opportunity for individuals to use the public comment portion of debate to demonize Israel, Zionists and Jews and engage in other forms of antisemitic speech.

While it is welcome and appropriate for the City of Santa Ana to condemn "the recent rise of Islamophobia, Antisemitism, racist, homophobic, and xenophobic attacks in our

Dear Honorable Members of the Santa Ana City Council,

On behalf of the Jewish community, we are writing to express our profound concerns regarding the resolution on the Israel-Hamas conflict scheduled for consideration during your meeting on Tuesday, March 5. This resolution, as currently proposed, is deeply flawed and dangerous, and will exacerbate divisions within our community at a time when unity is desperately needed.

Requesting Removal of Proposed Israel-Hamas Resolution

First, the conflict in Gaza is not a municipal issue. It falls beyond the subject matter jurisdiction of the Santa Ana city council. The conflict falls within the realms of the federal government, international organizations, and diplomatic efforts, and addressing them here is not within the purview of the council's municipal duties. Engaging in this matter distracts from the council's primary responsibilities and risks diverting attention and resources from local issues that directly impact the citizens of Santa Ana.

Second, such rhetoric has no place in the discourse of a city council that represents the diverse and vibrant community of Santa Ana. It is essential to recognize the complexity of the Israel-Hamas conflict without resorting to oversimplifications that only serve to inflame tensions and spread hate. For example, equating of Palestinian prisoners with Israeli hostages in the language of the resolution is egregious. This false equivalency is not only factually incorrect – as evidenced by Hamas' unwillingness to even identify remaining hostages – but also serves to propagate vile antisemitic tropes.

Requesting that City Council meetings are not used to promote hate speech

It is deeply troubling to us that because some councilmembers have decided to use City Council meetings as a platform for engaging their own beliefs on international politics, the council chambers have become a venue for antisemitic hate speech, particularly since October 7. Such rhetoric from councilmembers, whether inadvertent or purposeful, is aligned with the agenda of Hamas, who could bring about an immediate peace by returning the hostages and bodies of dead Israelis, and surrendering. The fact that some council members appear to support or even encourage this divisive and harmful behavior is unacceptable.

This hostility, often brought into our city by individuals from as far away as the Bay Area, threatens the very fabric of our local community. Jewish spaces, including our schools and synagogues, require armed security. Public schools have seen increases in bullying and antisemitic behavior against Jewish students, and teachers have begun to engage in curricular choices that have the potential to systemically drive Jew-hatred and bigotry into Santa Ana's schools.

While we appreciate that many local leaders, including Mayor Amezcua and Congressman Correa, have been working diligently to address rising hate in Santa Ana, other members of this body continue to engage in symbolic gestures that play into a dangerous narrative that does nothing to advance peace or understanding. Their actions only risk further alienating and endangering members of our community.

Hi Councilmember Vazquez,

I read the Requested Item Report as the premise for what is written in the ceasefire resolution that will be heard at the upcoming council meeting. I also read the proposed resolution. I'd like to bring up a few concerns to your attention:

1. The Requested Item Report provides a few statistics, however, I think you missed a few. I think it is warranted to provide the number of hostages taken on October 7th. Since you parse out how many Palestinian children have died in Gaza, will you please provide the number of children who were brutally murdered on October 7th? Additionally, please include the number of children that were taken hostage on October 7th. Will you also include the number of children that are still being held hostage in Gaza? How many total people are still hostages? This will provide clarity about why Israel is trying to eradicate Hamas and save hostage lives, two of which were rescued a few days ago.

Since you are keen on identifying how long Gaza has been under siege (121 days), will you please provide the number of days the Israelis have been hostages. I think it's approaching 140 days. I'll let you do the research.

By the way, will you also provide the number of Palestinians that Hamas has killed since 2005. There were a few they killed when they accidentally fired a rocket at one of their hospitals recently. I must say that most Palestinians that Hamas has killed has been intentional.

2. The Requested Item Report mentions that, "over 25,000 innocent Palestinian civilians", have been killed. Many people have lost their lives and that is tragic. It is well documented that civilians (non-Hamas members) assisted Hamas on October 7th and beyond. I think it is difficult to call all 25,000 of those people as "innocent". Further, I assume that the 25,000 number includes members of Hamas. Again, that is an assumption of mine. How do you know that all 25,000 people are "innocent"?

3. The Requested Item Report affirms city "support for an immediate ceasefire resolution, where the state of Israel declares a permanent ceasefire over Gaza...". The resolution is titled 'A Resolution of the City Council of Santa Ana, California Affirming Support for the worldwide call for an Immediate Ceasefire in Gaza'. It is abhorrent that these documents only support a one-sided ceasefire. Hamas is on record by saying they will commit more October 7th style attacks on Israel in the future. It is well documented. Yet, based on how your documents are written, the city of Santa Ana would be fine with that sort of attack again. Those types of attacks will not stand and I am in favor of Israel destroying Hamas to save future Israeli lives. These documents drip with anti-Semitic and anti-Israel notions.

I'm glad the resolution language calls for the release of hostages and I think everyone wants a ceasefire. The underlying issue here is that if you approve this type of resolution, the pro-Palestinian/Hamas folks will spin it as if the the City of Santa Ana outright condemns and blames Israel for what is happening. Based on the title of the resolution, I suppose they could make that leap. Anecdotaly, after a lot of research, the City of Long Beach passed a very vanilla, down-the-fairway resolution and the pro-Palestinian/Hamas folks have twisted it with the media as if it is a document that condemns Israel.

Please do not become a pawn. Please do not pass a ceasefire resolution.
