The City of Santa Ana encourages the public to participate in the decision-making process. The following notice is being provided so that you can ask questions, make comments, and stay informed about projects that might be important to you. We encourage you to contact us if you have any questions.

NOTICE IS HEREBY GIVEN The Community Development Commission and the City Council will hold two Public Hearings to receive public testimony and input on funding priorities and community needs for the FY 2024-2025 Annual Action Plan for the U.S. Department of Housing and Urban Development (HUD) funded housing, community development, and homeless programs.

In accordance with City of Santa Ana's Citizen Participation Plan, the City shall conduct two annual public hearings to accept public comments and feedback on funding priorities and needs for housing, community development, and homeless programs funded through the HUD Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), and Emergency Solutions Grant (ESG) programs. The City anticipates to receive the following grant amounts for FY 2024-2025: CDBG: \$4,808,057; HOME: \$1,605,667; and ESG: 447,249. Plan Review and Comment

The draft Action Plan incorporating the City's proposed uses of CDBG, HOME, and ESG funds shall be made available for public review for a 30-day period. In a manner similar to that set forth for the Consolidated Plan, the City shall encourage participation from all residents, especially low- and moderate-income residents, minorities, non-English speakers, and those with disabilities. The City shall make the plan accessible to all such groups from March 15, 2024 to April 15, 2024.

The City shall place an adequate supply of the draft Annual Action Plan for public review at the following locations: Community Development Agency 20 Civic Center Plaza, 6th Floor, Office of the City Clerk 20 Civic Center Plaza, Room 809, and Santa Ana Main Public Library 26 Civic Center Plaza, Santa Ana, CA 92702. Background on the Annual Action Plan

The Annual Action Plan establishes the activities to address the priority needs and Strategic Plan goals established in the City's 5-year Consolidated Plan. The priority needs established in the current



Consolidated Plan are: 1) Expand the supply of affordable housing; 2) Preserve the supply of affordable housing; 3) Access to and supply of public services; 4) Increase access to and supply of homeless services and facilities; 5) Promote economic opportunity; and 6) Improve City public facilities and infrastructure. 
