Masks Are Always Required

- Public transit
- Hospitals
- Long-Term care facilities
- Homeless shelters, emergency shelters, and cooling centers
- State and local correctional facilities and detention centers
- Indoors in K-12 schools, childcare, and other youth settings



When to Wear a Mask if You're Unvaccinated

- All the time when indoors
- Unvaccinated people are encouraged to wear face coverings in crowded outdoor settings or during activities that involve sustained close contact with other people who are not fully vaccinated.

- The City of Santa Ana strongly encourages everyone, whether fully vaccinated or not, to wear a face covering indoors.



Vaccine Requirements for City Employees

- Employers have the authority to require COVID-19 vaccines for employees.
 - Employers must provide a reasonable accommodation.
 - i.e., regular testing in lieu of a vaccination



Other Cities that will Require Vaccines for Employees

- City and County of San Francisco
 - Employees must report vaccination status to the City by July 29, 2021.
 - Employees must be fully vaccinated no later than 10 weeks after the FDA gives final approval of at least one COVID-19 vaccine.
- City of Pasadena
 - policy will require all City employees to be vaccinated once one of the a COVID-19 vaccine receives full approval from the FDA.
- City of Long Beach
 - No policy guidance yet.
 - The city manager is proposing to require vaccinations or mandatory weekly testing.
- City of San Diego
 - No policy guidance yet.
 - City officials are negotiating a mandate with labor groups relating to a policy requiring vaccines for City employees.
- County of San Diego
 - No policy guidance yet.
 - According to a tweet from @SanDiegoCounty, all County employees will be required to be vaccinated or get tested weekly and wear face coverings while indoors.
 - There will be disciplinary action takes against those who do not comply.

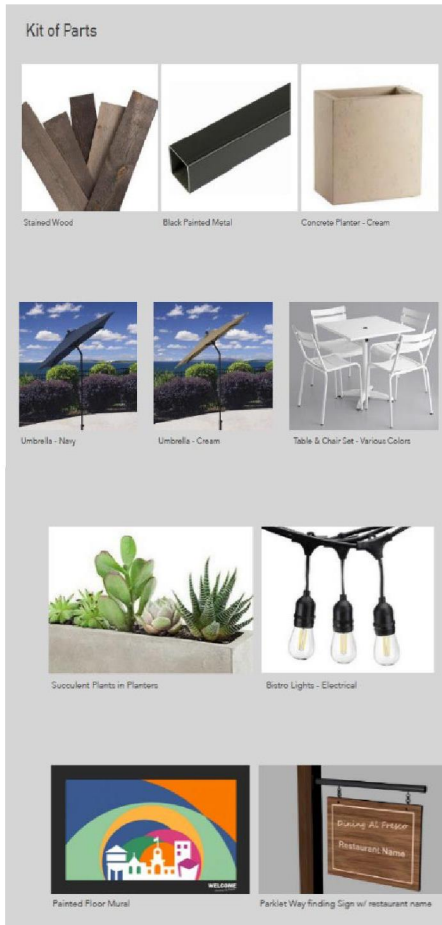
Standard Dining Patio – Design Sample
