Subject: March 11,2022 Special City Council Meeting on Redistricting


I found it disingenuous to hear at the March 7th City Council meeting that the public may still submit redistricting maps. If maps are still being accepted then why do we not see them listed in the March 11, 2022 City Council Agenda? The City Council, with the assistance of Redistricting Partners, redrew five maps at the March 7th meeting. These five maps, along with the breakdown/analysis, are included in the March 11, 2022 City Council agenda. A map submitted on February 25,2022 has not been included or evaluated. Nine additional maps have been submitted since the March 7th meeting and they too are not included in the agenda. I assume these will gather dust as well.

Your voiced concerns about the lack of community participating ring hollow when you do not recognize the efforts of those who are participating. Is it really that the community is not participating or that you do not like what the community has to say?

The number of neighborhoods that will have more than one councilmember representing them is not being published. I see no reason to take the time to determine this since it was obvious at the last meeting it is not a concern of the council.
