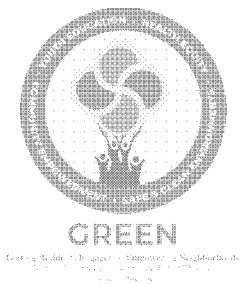

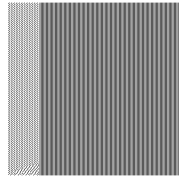

**Subject: ITEM 8 – City of Santa Ana 2022 General Plan Annual Progress Report**

I would like to commend the City for the progress towards meeting the Regional Housing Needs Allocation (RHNA) goals for the for the 6<sup>th</sup> cycle planning period (2021-2029). At this rate, and with all the major planning projects that are currently listed, the City is in the position to once again receive a rating of A+ for all categories. This is an unfortunate situation. I say this because with current rules we are not able to get credit for any excess units against the future RHNA cycle goals established by SCAG. It will be as if they were never built. Therefore, each time we exceed the goals we are jeopardizing our ability to achieve future RHNA cycle goals.

I would like to encourage the City Council to start the process now to work with SCAG to fix some of the inequities that exist in determining RHNA goals. At a minimum, cities, and specifically the City of Santa Ana should be compensated for exceeding RNHA goals. Available land use and density should also be considered when developing the RHNA goals.

**Please start now in lobbying for these changes.**

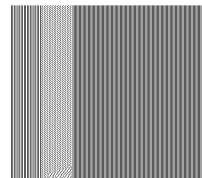
