### NOTICE OF PUBLIC HEARING BEFORE THE SANTA ANA PLANNING COMMISSION

**The City of Santa Ana encourages the public to participate in the decision-making process. This notice is being provided to all interested parties that have expressed interest in the proposed action or that live within a 500' radius of the proposed project so that you can ask questions, make comments and stay informed about projects that might be important to you. We encourage you to contact us prior to the Public Hearing if you have any questions.**

Planning Commission Action Items - The Planning Commission will hold a Public Hearing to receive public testimony, and will take action on the items described below. The Planning Commission decision is final unless appealed within 10 days of the decision by any interested party or group.

What is the Proposed Project? - The applicant is requesting approval of Regional Planned Sign Program No. 2018-01 as conditioned to allow the construction of a variety of temporary and permanent wall and digital signs at the existing Discovery Cube of Orange County development located at 2500 South Main Street in the Specific Development No. 65 (SD-65) zone. The signs are intended to identify the Discovery Cube and promote upcoming rotating and/or special exhibits.

Environmental Impact - In accordance with the California Environmental Quality Act (CEQA), the proposed project is exempt from further review pursuant to Section 15311 of the CEQA Guidelines because the proposed project does not have potential to cause a significant effect on the environment. Categorical Exemption ER No. 2019-33 will be filed for this project.

Meeting Date, Time and Location - This matter will be heard on **Monday, April 8, 2019 at 5:30 p.m.** in the City Council Chambers, 22 Civic Center Plaza, Santa Ana, California 92701. All persons interested in this matter are notified to appear at this time.

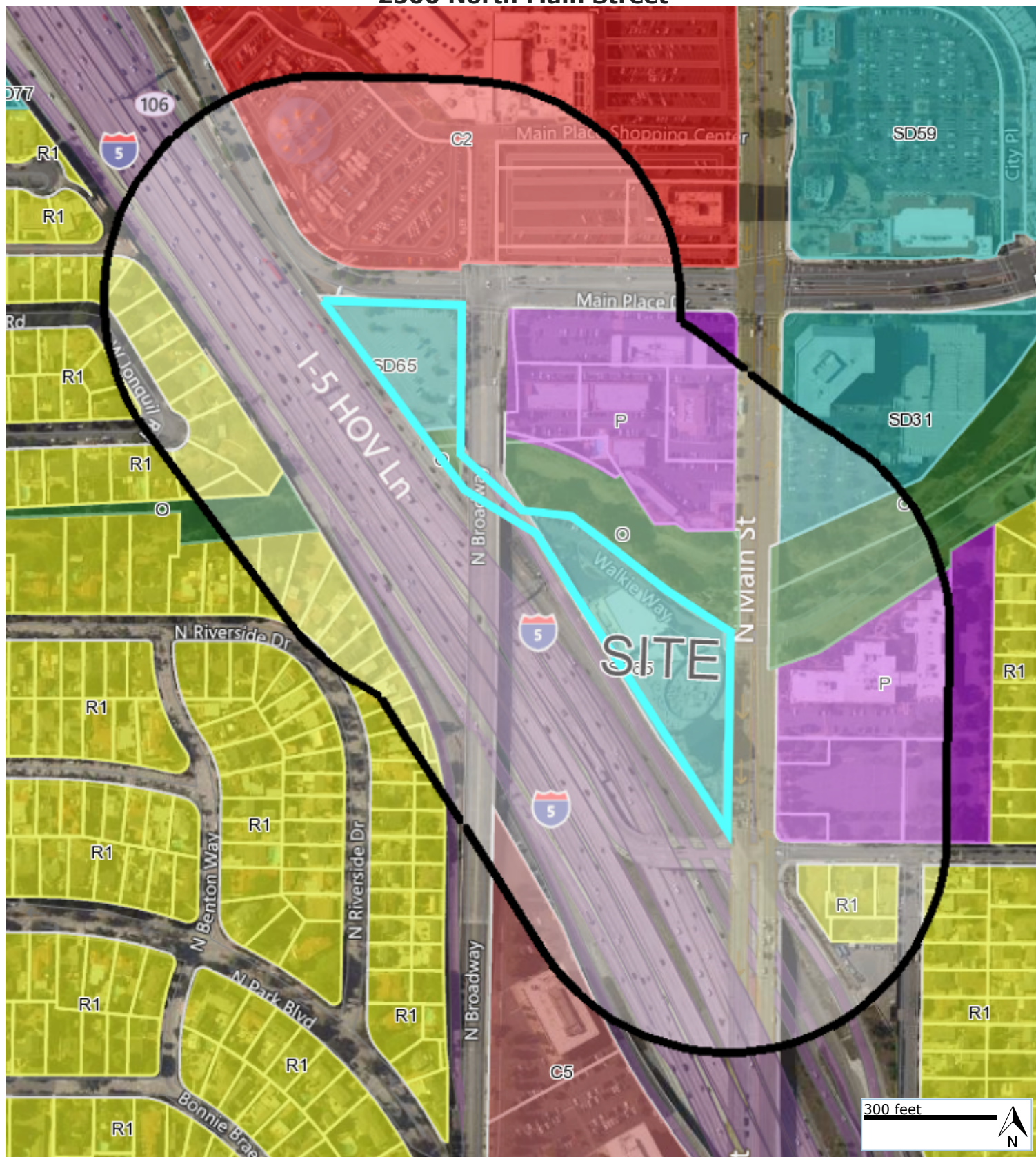
