**TOPIC:** Amend Blanket Purchase Order for Plumbing Services

### **AGENDA TITLE**

Amend the Blanket Order Contract with Horizons Construction Co., Pro-Craft Construction, Inc., and Verne's Plumbing for Plumbing Services by Increasing it to an Annual Aggregate Amount Not to Exceed \$370,000 for the Remainder of the Contract Term. (Specification No. 20-118) (General and Non-General Fund)

## **RECOMMENDED ACTION**

Authorize an amendment to the blanket purchase order contracts with Horizons Construction Co., Pro-Craft Construction, Inc., and Verne's Plumbing for plumbing services to increase the annual amount by \$165,000, for a revised annual aggregate amount not to exceed \$370,000, for the remainder of the current one-year term expiring September 30, 2023, and two one-year renewal periods, subject to non-substantive changes approved by the City Manager and City Attorney.

#### **DISCUSSION**

On October 20, 2020, at the conclusion of a competitive bidding process, the City Council approved blanket purchase order contracts with Horizons Construction Co., Pro-Craft Construction, Inc., and Verne's Plumbing for a two-year period from October 1, 2020 to September 30, 2022, with provisions for three one-year renewal options. The services provided through these contracts are used by various City departments for general plumbing repairs, modifications, and renovations. With the recent adoption of the City's FY22-23 budget, the City Council approved an additional \$2.5 Million for park maintenance. The additional funding will support anticipated plumbing repairs throughout various City parks along with other enhanced services.

Due to the age of City facilities and ongoing capital improvement projects, staff recommends increasing the blanket purchase order contracts for plumbing services by an aggregate amount of \$165,000, for a revised annual aggregate amount not to exceed \$370,000 for the remainder of the agreement term.

## **ENVIRONMENTAL IMPACT**

There is no environmental impact associated with the action.
