I am advocating for the permit system to be changed so that condo owners have access to it. Currently, it is only available to those with single family homes and the few multifamily homes with 4 units or less. That is decidedly unfair.

I am a citizen who pays property taxes just like they do, but I am unable to park near my home other than my one assigned spot. I live in a 2 bedroom condo and am limited to having either just one car or to park on a dangerous street and walk a mile in, since the city has converted all public streets to permit parking. My niece lives with me and we haven't gotten her a car yet because she is young, beautiful, and I am terrified of her walking alone at night for a mile. I too am a single woman who would be walking alone at night and in danger. We have heard all about the people stalking others walking in, the broken car windows they come to in the morning, and the stolen car parts. The danger is worsened immediately by city policies that discriminate against anyone but a single family home owner, who has by far the most resources and needs public street parking the least. Why are those who need something the least allowed to hog all the resources? Why can't we all be allowed to share what we all pay for?

My fellow residents and I have struggled for many years with the permit parking program that surrounds our condos.
